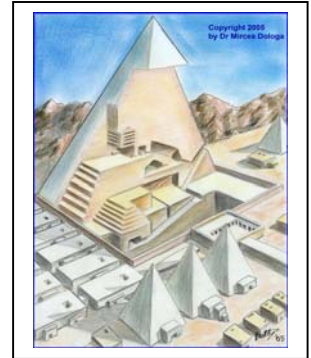

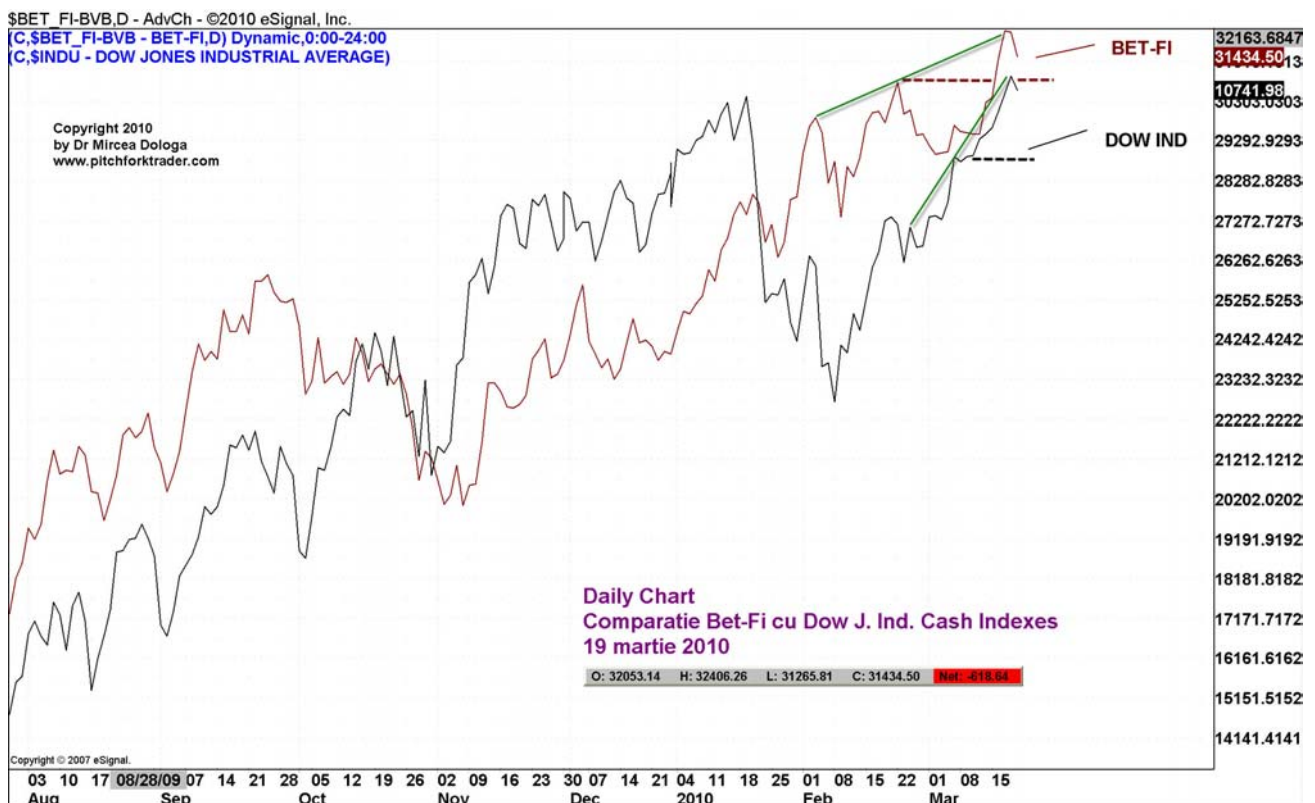


Traderul trebuie sa urmareasca in mod constant conditiile in care evolueaza piata, conditii care pot valida sau invalida estimarile facute in prezentul raport. Rezultatele studiilor de mai jos reprezinta estimari derivate din studii tehnice cu probabilitate mare de succes, dar nu sunt exacte in proportie de 100%. Ele pot fi re-analizate iar rezultatul final poate fi influentat de diverse evenimente. Un trader experimentat actioneaza intotdeauna tinand seama de directia pietei, nu doar de estimarile raportului.

Strategia pe care o folosim recomanda in primul rand o analiza top-down a pietei inaintea altor proceduri. In opinia noastra analiza de tipul Cash Index este mai sugestiva decat analiza de tipul Futures Index. Totusi, avand in vedere preferintele de tranzactionare a instrumentelor Futures, vom folosi de fiecare data genul de analiza adecvat fiecarui instrument tranzactionat.

In timpul studiului personal a realizat ca literatura de specialitate si seminariile sufera de o lipsa pronuntata de instrumentelor de utilitate practica, adica adevaratul 'know how'. 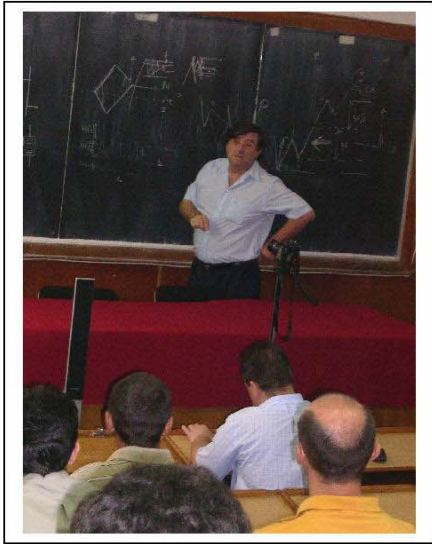

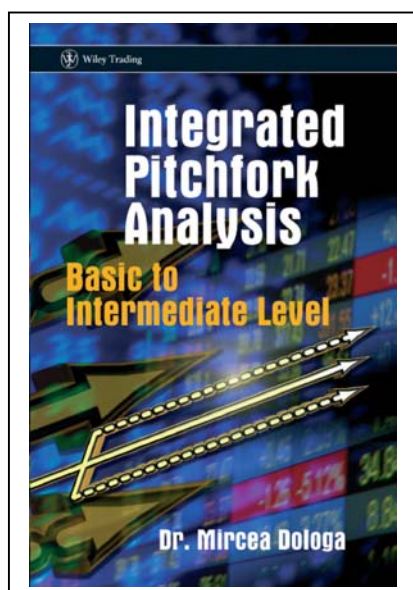

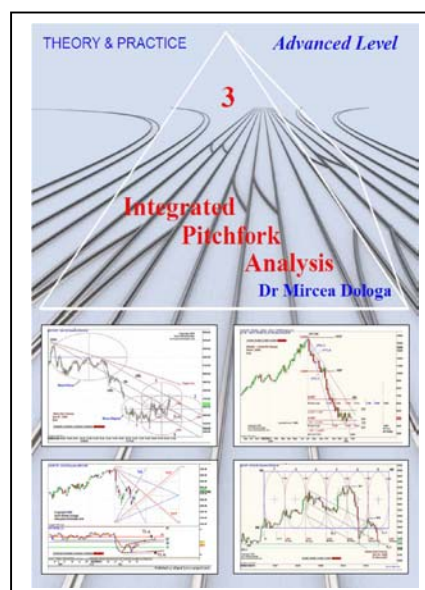
